Fisher Investments Institutional Global Developed Equity ESG Fund (the "Fund") a sub-fund of Fisher Investments Institutional Funds plc (the "Company") A2 Class Shares (unhedged) (IE00BD9BTM93)

Manufacturer: This product is manufactured and managed by Carne Global Fund Managers (Ireland) Limited (the "Manager"), with Fisher Investments acting as the Fund's investment manager (the "Investment Manager").

The Central Bank of Ireland (the "Central Bank") is responsible for supervising the Manager in relation to this Key Information Document. The Fund and the Manager are authorised in Ireland and regulated by the Central Bank.

What is this product?

Type:

This product is a sub-fund of an Irish UCITS investment company.

Term:

The Fund is open-ended. This Fund has no fixed investment term or maturity date, but may be terminated in accordance with the terms set out in the Prospectus.

Objectives:

Investment Objective:

The investment objective of this actively managed Fund is to outperform the MSCI World Index (the "Benchmark"). There is no guarantee that the investment objective will be achieved. The Fund is actively managed by the Investment Manager, meaning that investment decisions are made on a fully discretionary basis. Accordingly, the portfolio holdings may deviate from the Benchmark. This deviation may be material.

Investment Policy:

The Fund invests:

- Primarily in equities and equity-related securities of, or linked to, issuers that are included in the country indices represented within the Benchmark.
- Up to 20% of its total assets in equities and equity-related securities of companies established in countries not represented within the Benchmark.
- Up to 10% of its total assets in unlisted equities.

While the Fund will invest primarily in equities and equity-related securities, as referred to above, the Fund may for liquidity, hedging and/or cash management purposes, in circumstances of extreme volatility or if market factors require and if considered appropriate to the investment objective, invest on a short term basis in cash, cash equivalents, money market instruments or government or corporate bonds. Investments in other funds will not be more than 10% of the Fund's total assets.

The Investment Manager considers environmental, social and governance ("ESG") factors, including ESG events or conditions that, if they occur, could cause a negative material impact on the value of an investment ("Sustainability Risk"), throughout the investment and portfolio construction process. ESG factors, including Sustainability Risk, are among the many drivers considered by the Investment Manager when developing country, sector and thematic preferences. Governmental influence on public companies, environmental regulation, social policy, market reforms impacting private property, labour, and human rights are among ESG factors considered when determining country and sector/industry allocations and shaping an initial prospect list of portfolio positions.

The Investment Manager performs fundamental research on prospective investments to identify securities with strategic attributes consistent with the Investment Manager's top-down views and with competitive advantages relative to their defined peer group. The fundamental research process involves reviewing and evaluating a range of ESG factors prior to purchasing a security, seeking to identify securities benefitting from ESG trends and avoid those with underappreciated risks. These factors include, but are not limited to,

shareholder concentration, corporate stewardship, environmental opportunities and liabilities, and human or labour rights controversies.

The Investment Manager believes its consideration of ESG factors and Sustainability Risks, as described above, is an important element in contributing towards long-term investment returns and an effective risk-mitigation technique. However, Sustainability Risks may nonetheless adversely impact the Fund's performance.

In addition, the Fund promotes environmental and social characteristics. While it does not have as its objective a sustainable investment as defined under SFDR (a "Sustainable Investment"), it will have a minimum proportion of 5% of Sustainable Investments with an environmental or social objective.

The Fund may use investment techniques (known as derivatives), but only to reduce or protect against risk, reduce costs, and generate income or capital with appropriate risk. Furthermore, the Fund may use these techniques if controlled by the Fund's risk management process.

The return on your investment in the Fund is directly related to the value of the underlying assets of the Fund, less costs (see "What are the costs" below).

Income: Income from the Fund's investments will not be paid out in dividends (except for the distributing D3 Share Class, which will distribute income in accordance with the distributing policy set out in the Supplement).

Redemption of Shares: You can typically sell shares in the Fund on any business day (as set out in the Fund's supplement).

Sub-Funds: The Fund is one sub-fund within the Company. This Key Information document is specific only to the Fund. The Prospectus and semiannual reports are prepared for the entire Company, including all sub-funds. The assets and liabilities of each sub-fund are held separately from the other subfunds. This means your investment in the Fund will not be affected by claims made against any other sub-fund. The segregation of assets is based on Irish law and these provisions have not been tested in other jurisdictions.

You may exchange shares of one sub-fund for shares in another sub-fund by selling the shares of the first sub-fund and purchasing shares of the other sub-fund as described in the Prospectus.

The assets of the Fund are held in safekeeping by its depositary, State Street Custodial Services (Ireland) Limited (the "Depositary").

Intended retail investor:

The Fund is intended for investors (i) who do not intend to withdraw their money within 5 years; (ii) who are prepared to accept a significant degree of volatility; (iii) that have the ability to bear losses in order to seek to generate higher potential returns; and (iv) who are advanced investors who have a good knowledge and experience of these products or basic / informed investors who purchase with investment advice or through a discretionary portfolio service.

What are the risks and what could I get in return? Risk Indicator



The actual risk can vary significantly if you cash in before the recommended holding period and you may get back less. However, your liability will be limited to the amount invested and you will not be liable for any additional financial commitments beyond the amount you have invested. The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level and poor market conditions could impact the value of your investment.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

What happens if the Manager is unable to pay out?

In the event of the insolvency of the Manager, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss and there is no compensation or guarantee scheme in place which may offset, all or any of, this loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund.

What are the costs?

Costs over time

Recommended holding period: 5 years
